- Revenues up from last year.
- •Expenditures up from last year.

#### Sewer

- ●No SAW grants.
- •Expenditures down from last year.
- Need to supervise this fund during the year.

#### Water

- •Operating expenses up from last year.
- Need to supervise this fund during the year.

The Mason County Rural Fire Authority Minutes were submitted for review.

## REPORTS CITY MANAGER

- •Two new homes met zoning requirements and will be built in the Sweetwater Subdivision. The foundation for one of them has already begun. Williams noted these are not stick built homes.
- •The Michigan Municipal Risk Management Authority sent notification to Williams that the City has been approved grant money to purchase two new Taser's for the police department.
- •The City has been approved grant money through Great Lakes Energy People's Fund Grant Program to purchase two AED's, which will be placed in the office of City Hall and in the second police cruiser.
- •Winter parking restrictions are in force from November 1 through April 1.
- Winter tax bills will be mailed out at the end of November.
- •City Hall will be closed November 22 and 23 in observance of the Thanksgiving holiday.

#### **OLD BUSINESS**

Earlier in the year a new fee schedule was approved, which will result in changes being made to the cost of purchasing cemetery sites and burials at Brookside Cemetery for non-residents. Originally the rate that was charged to anyone using those services, whether you were a resident of the City or a non-resident of the City, was the same. Now anyone using those services will be charged a fee based upon their resident or non-resident status. An additional fee of \$100 will be added to the cost of any Saturday burials. A resident is defined as anyone owning a residential property within the City and includes their spouse and any minor children 18 years or younger. Motion, by Cole and seconded by Duncil, to approve the changes to the Brookside Cemetery Rules and Regulations booklet. Motion carried.

#### **NEW BUSINESS**

The one-year and three-year terms for the Board of Review will expire the end of the year. Julie Deller (one-year term) and Diana Kovalchik (three-year term) have agreed to serve another term. Motion, by Spencer and seconded by Alway, to approve the appointments to the Board of Review as presented. Motion carried.
