REPORTS:

A. City Manager:

Report provided. Interim Murphy commented that he is working diligently with office staff to accommodate his new workload. There are a lot of moving parts, but he is confident in the positive productivity featured in the upcoming weeks.

B. City Attorney:

Alvarado reported since the last meeting he has attended an Ordinance Committee meeting, drafted a number of Resolutions on behalf of the City, and is currently working with a resident on a Brookside Cemetery plot buy back. Alvarado will comment on other topics further on the agenda.

C. Police Department:

Chief Murphy introduced the new School Resource Officer Steve Case. Steve thanked the City for the opportunity and expressed his excitement to get started building relationships within the school systems and learning the outlay of both campuses.

D. Treasurer:

Treasurer Shafer presented the Revenue and Expenditure Report, as well as the bills for the current payment cycle.

C. Conservation Resource Alliance Presentation:

Representative DJ Shook brought forth a presentation concerning bank erosion at River Side Park. The Conservation Resource Alliance has a recommendation moving forward to help repair and prevent further erosion. According to their records the City of Scottville had previously made a commitment of \$10,000 to this project. Video report provided. Copies were made available to Commissioners in packet. Mayor Spencer recommended the Commission refer this to Finance Committee for further consideration.

D. Revenue Sharing Reports:

Wednesday 11/25/2020 the City was made aware by the State of Michigan Department of Treasury that the Revenue Sharing Reports had not been returned by Manager Magaluk. With a pending deadline of 12/01/2020 interim Murphy reported that both himself and Treasurer Shafer worked through the Thanksgiving holiday to ensure reports were submitted on time. After many hours of overtime, Treasurer Shafer secured the \$47,000 the City was at risk of forfeiting.

Revenue Sharing Report 20-159 Motion, by Alway and seconded by Cole to appoint the Acting City Manager, the Mayor and the City Attorney to perform an investigation to determine why the timely preparation of the Revenue Sharing Report for 2020 was overlooked, who is responsible for such deficiency, if any, and to determine whether there are other reports or tasks that may not have been performed.

<u>Bruce Krieger 509 S Main</u> commented he is working on fundraising and local grants to assist with the cost of the erosion control project at Riverside Park.

COMMISSIONER COMMENT:

Mayor Spencer welcomed Commissioner Claveau.

She commented that she was able to attend MML's Community Stabilization Conference covering Revenue Sharing, Revenue replacement ideas and requesting municipalities to reach out to the Senate and House to extend virtual meetings beyond December 31st 2020.

She thanked Interim Murphy and Treasurer Shafer for their diligence in ensuring our Revenue Sharing paperwork was finished and submitted on time.

She praised the Police Department for their work with Habitat for Humanity, and for the Christmas decorations put up down-town.
