#### **REPORTS:**

- A. <u>City Manager</u>: Report provided. Magaluk is taking a proactive approach in preparation for the recent health concerns surrounding the COVID-19 crisis. City Hall is encouraging residents to utilize our online resources for payments and information. Magaluk is waiting on additional guidance from Governor Whitmer in regards to the Open Meetings Act. Whitmer has issued an executive order allowing the employment of different communication options in the fulfillment of our legal obligations, and wellbeing of staff and community members alike. Lastly Magaluk noted we will be partnering again this year with Mason Lake Conservation District on the removal of some invasive species at Riverside Park. This process is 100% grant supported.
- B. City Attorney: No report provided.
  - a. Thompson announced that he will not be applying for the City Attorney position. He has served The City of Scottville for 23 years, and feels it's a positive step forward to open the position to other prospective contractors. He will remain on board until a suitable replacement is found.
- C. Police Department: Report provided. Chief Murphy added he has been working diligently with other local agencies in emergency preparedness training. A handful of local restaurants were ordered to shut down table service by 3 o'clock this afternoon per Governor Whitmer's order. Murphy asked that residents show compassion to our residents who are suffering due to the COVID-19 crisis. The pursuit of truancy violations is a continuing effort, but has been going well.
