Newkirk reported the DPW has been busy with Spring chores. McPhail Field, Riverside Park and Brookside Cemetery have opened for the season. May Special Election went well. Interviews for the vacant DPW position will begin 6/1/21. Many zoning permits for home repairs and projects have been submitted by residents.

Newkirk commented on the letter submitted referencing a situation involving a current City employee that generated a police report. The incident occurred outside of City limits, on the employee's own time. The Prosecuting Attorney dismissed the case without charge. The employee was reprimanded accordingly and referred to outside counseling services. The Personnel Committee and Newkirk consider the matter closed.

Murphy and Spencer have been working closely with Newkirk to bring the CM up to date on the happenings within the city. Office and DPW staff have been readily available to ease the transition between Murphy and Newkirk. The city has been bustling with good vibes!

Alvarado has also been working closely with Newkirk to bring him up to date on current legal matters. He has executed 3 FOIA requests. He commented on a specific letter from communications; submitted by a resident announcing intent to sue The City of Scottville. His legal counsel provides the "intent to sue" does not adhere to Michigan law, which is reserved for personal injury/malpractice suites, not administrative cases.

Public feedback noted issues with 2 presented items, Seasonal rate increase and number of Seasonal sites. Spencer offered the reasoning for the price increase being overdue repairs to the park. The in-ground infrastructure systems are in dire need of attention. Benyo commented our fee schedule including the increases is still quite comparable to other Campgrounds. Graham suggested maybe a 60/40 increase noting such a large increase all at once rather than a gradual increase is the cause for concern to most campers. No person shall keep chickens unless they obtain a backyard chicken permit and comply with the following conditions:

- 1. The keeping of chickens is permitted only on lots where the principal use is a single family dwelling.
- 2. The maximum number of chickens permitted per property shall be six (6) Roosters are prohibited.
- 3. Chickens must be maintained in a fully enclosed, roofed structure at all times.
- 4. The enclosure must be constructed of permanent residential building materials suited for the purpose intended, and in a manner which serves to enhance the aesthetic appearance of the neighborhood or surrounding area.
- 5. All areas accessible to the chickens, including the coop and run, shall be contained in a single structure not to exceed sixty (60) square feet in footprint and eight (8) feet in height measured from the grade. The minimum run size per chicken shall be eight (8) square feet.
- 6. The enclosure must have chicken wire or similar material embedded twelve (12) inches into the ground around the enclosure to deter predators from digging under the enclosure wall.
- 7. The enclosure shall be located in the rear yard and at least eight (8) feel from side and rear property lines, and where public sidewalk is present at least ten (10) feet distant from it.
- 8. The enclosure must be maintained in a clean and orderly fashion.
- 9. Chicken feed must be kept in a vermin-proof sealed container.
- 10. Slaughtering of chickens is not permitted.
- The applicant shall pay the fee required by the fee resolution periodically adopted by the City Council.
- 12. Applications for backyard chicken permits shall be submitted to and permits shall be issued by the City of Scottville.
- 13. An initial backyard chicken permit shall be valid for 1 year, renewed yearly on April 1.
- 14. Upon sale or transfer of property, the chickens and enclosure must be removed from the premises within sixty (60) days.
- 15. Permit is not transferable
- 16. Applications for a backyard chicken permit, suspensions, and revocations shall be handled in the manner provided in chapter 153
