b. <u>Introduction of Ordinance 24-04 to Amend Ordinance 153; Self Storage Facilities in Highway/Commercial District.</u>

Fischer Self Storage Representative (Doug Fischer) present for questions on project plan. Motion, by Wyman with support from Spore to approve the introduction of Ordinance 24-05 to Amend Ordinance 153, allowing self-storage in a highway/commercial district. c. Introduction of Ordinance 24-05 to Amend Ordinance 93; Prohibiting Ingress/Egress on banks at Riverside Park.

Discussion over launching and landing of watercrafts along the bank of the Pere Marquette River within Riverside Park. The city to face a potential fine from the Conservation Resource Alliance for misuse of the grant funded prevention of erosion of the riverbank if regulations are not established. First offense of \$250, second up to \$500 to be monitored by the SPD amongst parking pass monitoring. Staff at Riverside campground would be included in this process.

Motion, by Spore with support from Jensen to approve the introduction of Ordinance 24-05 as an amendment to existing Ordinance 93; Regulations for use of Pere Marquette River in Riverside Park.

d. <u>Dangler Resignation DDA/Planning Commission</u>.

Motion, by Jensen with support from Wyman to accept Myndi Dangler's resignation from both the Downtown Development Authority Board and the Planning Commission. Motion carried.

e. Boat Launch and Fish Cleaning Station.

Discussion of needed repair of the grinder pump at the fish cleaning station, and the best course of action moving forward with this property. No action taken.

f. No Response from Norland and Associates Concerning Reimbursement Request from Water Main Rupture.

Goodlein reported there has been no contact or action taken from Norland and Associates regarding the water main rupture in May of 2024. To date, two invoices have been sent from city administration without response. The surrounding effected municipalities (City of Ludington) have also been unsuccessful with reimbursement requests.

Motion, by Wyman with support from Spore to direct Attorney Nettleton to send written communication to Norland and Associates on behalf of The City of Scottville as a final reimbursement request prior to legal proceedings.

g. <u>Discussion of Interim City Managers Evaluation and Consideration of New Work Agreement.</u>

The personnel committee collected reviews from commissioners and staff on the performance of Interim City Manager Clarence Goodlein. Goodlein scored 329/330 potential points, with several positive comments. The current contract is set to expire in early December 2024. Terms, length and compensation to be negotiated. Motion, by Wyman with support from Copenhaver to direct Attorney Nettleton to draft a potential contract for continued services provided by Clarence Goodlein. Motion carried.

h. Thue Resignation

Per city charter, and due to it being less than 60 days prior to a General Election, the seat is not required to be filled immediately. Due to Thue submitting a petition to Clerk Lester, hence being on the ballot and per the direction of legal counsel, after 11/5/24 (general election) a second letter of resignation should be submitted by Thue, a second declaration of vacancy will be announced after which letters of interest may be submitted to city administration to fill this term.

- Discussion with the Police Department and the City Attorney concerning the application of certain City Ordinances to property acquired through a PA 425 of 1984 action, and that is located north of the City and near the US 31 Bypass.
- Review of specifications and stipulations required for the authoring of a request for proposals (RFP) concerning a study and recommendations for water and waste-water ready-to-serve rates and cash reserves required for future capital improvements of both water and waste-water systems as well as financial projections of what monies current and proposed water and waste-water rates would provide.
- Development, publication, and distribution of Administrative Directives concerning written work orders and assignment of a Human Resources Facilitator.
- Discussion with the City Treasurer concerning her assumption of duties as the Human Resources Facilitator for the City.
- Discussion with City Clerk concerning the status of fundraising and planning for the Scottville Children's Christmas Parade and Holiday Celebration.
- Meeting with a representative of the Mason County Press concerning the Financial Action Plan that was recently received and discussed by the City Commission.
- Continuation of the review of records related to the alley watermain project and the analysis and evaluation of design and construction engineering fees.
- Review and evaluation of all professional services agreements as well as vendors rendering professional services without an agreement currently.
- Discussion with SAFEbuilt representative concerning the issuance of ordinance violation notices for building code offenses as well as offenses of the rental regulations' ordinance.
- Discussion with the Department of Public Works concerning the status of sidewalks that have scheduled for replacement.

Committee to Introduce an Ordinance Amending §154.02 of Chapter 154 of Title XV of the Code of Ordinances of the City of Scottville – The Residential Rental

Property Regulations

Background: At its October 16, 2024 meeting, the Ordinance and Public Safety Committee received communication from the City Attorney concerning an amendment to the Residential Rental Property Regulations found in the City of Scottville's Code of Ordinances and that pertained to its definitions of Family Member and Rental Dwelling. Subsequently, the Committee discussed that communication and decided on criteria for each of these definitions. In this regard, the Committee decided that the definition of *Family Member* should be defined as "... a parent, grandparent, child or grandchild of the owner of the dwelling related by blood, adoption, or marriage" and that the definition of Rental Dwelling should be defined as "... any dwelling not occupied by the property owner or any family member(s), as defined by this Chapter. The owner of a dwelling occupied by any family member(s), as defined by this Chapter, shall annually file a non-rental affidavit with the City so as to have the dwelling be exempt from the requirements of this Chapter". It was the decision of the Ordinance and Public Safety Committee that these definitions would best serve both the purpose of the Residential Rental Property Regulations' Ordinance and the good of the community and that the Committee should recommend that these definitions be amended as stated and as shown in the proposed amending Ordinance that accompanies this memorandum. Lastly, the Committee decided that it was their recommendation that the City Commission introduce this amending ordinance this evening.

Recommendation: It is recommended that the City Commission accept the recommendations of the Ordinance and Public Safety Committee and introduce the proposed Ordinance that would amend §154.02 of Chapter 154 of Title XV of the Code of Ordinances of the City of Scottville, The Residential Rental Property Regulations, to change the definitions of *Family Member* and *Rental Dwelling* as shown in this report and the accompanying proposed Ordinance since it would best serve both the purpose of residential rental property regulations and the good of the community.

AN ORDINANCE TO AMEND SECTION 154.02 OF CHAPTER 154 OF TITLE XV OF THE CODE OF ORDINANCES OF THE CITY OF SCOTTVILLE - THE RESIDENTIAL RENTAL PROPERTY REGULATIONS

THE CITY OF SCOTTVILLE ORDAINS:

<u>Section 1.</u> <u>Amendment of Section 154.02 of Chapter 154 of Title XV of the City of Scottville Code of Ordinances.</u> Section 154.02 of Chapter 154 of Title XV of the City of Scottville Code of Ordinances is hereby amended in its entirety to read as follows:

Sec. 154.02. Definitions.

- (i) "Boarding House" shall be as defined in the Scottville Zoning Ordinance.
- (ii) "Building Inspector" means the Scottville City Manager or his or her designee in writing.
- (iii) "Certificate of Compliance" means a document issued by the Building Inspector stating the dwelling has passed inspection and complies with local codes and requirements.
- (iv) "Dwelling" means any house, room, boarding house or apartment, which is wholly or partially used or intended to be used for living, sleeping, cooking and eating. Hotels, motels, bed & breakfasts, and resorts shall not be defined as dwellings for the purposes of this chapter.
- (v) "Family member" means a parent, grandparent, child or grandchild of the owner of the dwelling related by blood, adoption, or marriage.

- (vi) "Fee" means a fee determined from time to time by Commission resolution.

 A fee shall be charged each time the Building Inspector makes an on-site inspection of any dwelling that comes within the meaning of this chapter.
- (vii) "Landlord" means any person, firm, partnership, association, corporation, company or organization of any kind owning or offering for rent or lease any dwelling or dwelling unit within the City.
- (viii) "Scottville Property Maintenance Code" shall be the Scottville Property Maintenance Code, Chapter 151, as amended.
- (ix) "Parcel" means a tract of land identified by a single parcel identification number on the property tax rolls of the City.
- (x) "Rental Dwelling" means any dwelling not occupied by the property owner or any family member(s) as defined by this chapter. The owner of a dwelling occupied by any family member(s), as defined by this chapter, shall annually file a non-rental affidavit with the City so as to have the dwelling be exempt from the requirements of this Chapter.
- (xi) "Rental Dwelling Unit" means a portion of a rental dwelling for an individual, couple, a single family, or other living unit.
- (xii) "Transfer of Ownership" means the conveyance of title to or a present interest in property, including the beneficial use of property, the value of which is substantially equal to the value of the fee interest.
- <u>Section 2</u>. <u>Severability</u>. The terms and provisions of this Ordinance shall be deemed to be severable, and should any section, clause or provision hereof be declared to be invalid, the same shall not affect the validity of any other section, clause, or provision of the ordinance, if the same may be given effect without the provisions thus declared to be invalid.
- <u>Section 3</u>. <u>Repeal</u>. All resolutions or ordinances, and parts thereof including, which are in conflict, in whole or in part, with any of the provisions of this Ordinance are hereby repealed.
- <u>Section 4.</u> <u>Effective Date; Publication.</u> This Ordinance shall become effective fifteen days after its adoption, but not before its publication pursuant to Section 7.18 of the City Charter, by making copies of the Ordinance available for inspection by, and distribution to, the public and by publishing notice of the printing and availability before the effective date herein.
