Subject: FY 2024-2025 Water Main Replacement Project - Notice Of Limited Road

Replacement

As you know, the City will begin replacing some of its watermains next year as a result of funding from the State of Michigan. Last week and during a meeting with the design and construction engineers for this project, it was confirmed that this funding did <u>not</u> provide for complete repaving or restoration of all streets/roadways that have been selected for watermain replacement. Consequently, and due to the City's lack of financial resources to fund the restoration or repaving of the remaining portions of these streets, some streets will be only partially restored or repaved after their watermains have been replaced. This notice is provided to City Commissioners since this occurrence will significantly diminish the longevity of the streets that will be partially repaved or restored. Commissioners can expect that sections of streets that have been partially repaved or restored may lose as much as 50% of their durability and lifespan¹ due to seams and transitions to old unrestored parts of these streets as well as the unequal deterioration rates of the new and old sections of these streets.

The following streets have been identified as those that will <u>not</u> be completely repaved or restored after their watermains have been replaced.

- South Elm south of Second.
- Blaine south of State.
- Broadway between North Main and Columbia.
- Gay between Broadway and Maple.
- Maple west of Reinberg.
- Beryl between Reinberg and Main.

¹ The lifespan of a city street is approximately 15-20 years and depends upon adequate drainage and sufficient maintenance.

The current 301 Police Budget used for the year is \$82,773. SVPD over all budget for 24/25 year is approximately \$13,050 dollars under budget.

Recommendation to Consider Enactment of an Ordinance Amending Chapter 153 of Title XV of the Code of Ordinances of the City of Scottville Zoning Ordinance

to Allow Self Storage Facilities in the Highway Commercial District as of Right

Background: At its September 03, 2024 meeting, the Planning Commission received a request from Fisher Self-Storage for conditional zoning of a 4.06 acre parcel, Parcel # 052-012-023-31, at 555 North Scottville Road near US 31 to allow for a self-storage facility as a use for the property. This property was acquired by the City of Scottville through annexation as authorized by PA 425 of 1984 (as amended) and is zoned as HC (Highway Commercial). Although this zoning designation might cause a conclusion that a self-storage facility would be authorized as a use by right or special use authorization, it is not. Parcels zoned as *Highway Commercial* are neither authorized for use/special use for warehouses nor storage facilities. Consequently, authorization from the Planning Commission and the City Commission is required through a Public Hearing process.

Since the Planning Commission's consideration of that request at its September 03, 2024 meeting and its approval for further consideration of conditional zoning of the parcel after a Public Hearing on October 01, 2024, City Administration discussed this matter further with the City Attorney during a number of meetings. As a result of those meetings and discussions, it was determined that it is in the best interest of the City that its Zoning Ordinance be amended to permit self-storage facilities in the Highway-Commercial zoning district as of right rather than proceed with conditional zoning of the parcel. Consequently, the City Attorney prepared a proposed Ordinance that contains a proposed text amendment to the City of Scottville's Code of Ordinances that would amend its Zoning Ordinance to allow for this change. Subsequently, a Public Notice of a Public Hearing concerning this text amendment to the Ordinance was scheduled for the Planning Commission meeting of October 01, 2024, and posted.

At the Planning Commission Meeting of October 01, 2024, a Public Hearing was conducted and, subsequently, the proposed Ordinance containing the proposed text amendment to the Zoning Ordinance was discussed by the members in attendance at that meeting. Consequently, this proposed Ordinance was approved by the Planning Commission for transmittal to the City

proposed Ordinance was approved by the Planning Commission for transmittal to the City Commission with a recommendation that the Commission consider and approve it for introduction at that meeting.

At the October 14, 2024 meeting of the City Commissioners met and after consideration of the Planning Commission's request to approve the proposed amendment to Chapter 153 of Title XV of the Code of Ordinances of the City of Scottville², the City Commission voted to approve the Ordinance amendment for the purpose of its introduction.

For Commissioners' use and reference, the following documents accompany this memorandum:

- An aerial view of the parcel.
- A copy of the survey document and report concerning the parcel.
- A design drawing of the proposed facility.
- A copy of the proposed City Ordinance.

Recommendation: It is recommended that the City Commission consider enactment of the proposed ordinance that would amend the text of Chapter 153 of Title XV of the Code of Ordinances of the City of Scottville Zoning Ordinance³ to allow self-storage facilities in the Highway Commercial District as of right; a copy of the proposed Ordinance accompanies this memorandum. It is City Administration's opinion that this amendment to the City's Code of Ordinances is in the best interest of the City.



ORDINANCE NO. 24-04

AN ORDINANCE TO AMEND CHAPTER 153 OF TITLE XV OF THE CODE OF ORDINANCES OF THE CITY OF SCOTTVILLE, THE CITY OF SCOTTVILLE ZONING ORDINANCE, AND MATTERS RELATED THERETO

[To add self-storage facility as permitted use in highway commercial district]

THE CITY OF SCOTTVILLE (the "City") ORDAINS:

Section 1. Amendment of Section 153.004 of Chapter 153 of Title XV of the City of Scottville Code of Ordinances. Section 153.004 of Chapter 153 of Title XV of the Scottville Code of Ordinances (the "City Code") is hereby amended to add the following definition in alphabetical order:

SELF-STORAGE FACILITY. Any real property designed or used for the purpose of renting or leasing individual storage space to tenants who are to have access to that space for the purpose of storing and removing personal property.

Section 2. Addition of a New Section, Section 153.219, to Chapter 153 of Title XV of the City of Scottville Code of Ordinances. A new section, Section 153.219, entitled "SELF-STORAGE FACILITY" is hereby added to Chapter 153 of Title XV of the City Code to read in its entirety as follows:

- § 153.219 SELF-STORAGE FACILITY.
- (A) Minimum lot area shall be two (2) acres.

- (B) Prior to construction of a self-storage facility, a site plan displaying the layout of the facility and a narrative describing the use of the facility and compliance with relevant Ordinances must be submitted to the Zoning Administrator.
- (C) Self-storage facilities must be completely enclosed in a secure fence of at least six feet (6') in height.
- (D) There must be at least one gate of twenty feet (20') in width or more to accommodate emergency vehicles.
- (E) All gates must be secured from unauthorized entry and equipped with "Knox Box" or similar emergency access device, located within the immediate vicinity of the gate.
- (F) Interior drive aisles or roadways shall not be less than twenty feet (20') in width.
- (G) All outdoor lighting must include an automatic timer which will turn off the light after one (1) hour without use. Outdoor lighting must be shielded to prevent illumination of the sky or adjacent properties.
- (H) Self-storage facilities, and structures within them, shall not be used for any activity other than the renting or leasing of space for storing and removing personal property. Prohibited uses include, but are not limited to, commercial, retail, industrial activities and use as a dwelling unit.

Section 3. Amendment of Appendix A of Chapter 153 of Title XV of the of the City of Scottville Code of Ordinances. Appendix A of Chapter 153 of Title XV of the City Code, entitled "TABLE OF USE REGULATIONS," is hereby amended to add the following as a Use Permitted as a Matter of Right within the HC – Highway Commercial Zoning District:

3. Self-Storage Facility

Section 4. Amendment of Appendix B of Chapter 153 of Title XV of the of the City of Scottville Code of Ordinances. Subject: Request for Enactment of a Proposed Ordinance to Amend Chapter 93 of Title IX

of the Code of Ordinances of the City of Scottville and Matters Related Thereto That Would Prohibit Ingress and Egress From the Riverbanks of Riverside Park Into the Pere Marquette River and Provide the City Manager With Authority to Make Rules and Regulations to Regulate the Use of Parks and Public Grounds With

City Commission Approval

Background: As you will recall from your discussion at the October 14, 2024 meeting of the City Commission, Commissioners discussed the need for regulation of the use of the riverbank at Riverside Park due to regulations of the Michigan Department of Natural Resources that require strict control of riverbank erosion and the need to easily implement rules and regulations for the use of City parks and public grounds. Subsequently, the City Commission considered a proposed amendment to the City of Scottville Code of Ordinances that would provide a means to accomplish each of these two requirements, and it approved the introduction of the aforementioned amendment to the City's Code of Ordinances.

Accompanying this memorandum is the proposed Ordinance that would amend the Code of Ordinances of the City of Scottville to prohibit riverbank use for ingress and egress into the river at Riverside Park and that would provide the City Manager with the authority to make rules and regulations, subject to the approval of the City Commission, pertaining to the use of parks and public grounds as is necessary to provide for the health, safety, morals, and welfare of the public. This proposed amendment to the City's Code of Ordinances is provided for Commissioners' information and consideration of whether the Commission should approve enactment of this Ordinance.

Recommendation: It is recommended that after discussion of the proposed Ordinance to amend Chapter 93 of Title IX of the Code of Ordinances of the City of Scottville, and matters related thereto, that would prohibit ingress and egress from the riverbanks of Riverside Park into the Pere Marquette River and that would provide the City Manager with authority to make rules and regulations to regulate the use of parks and public grounds with City Commission approval, the City Commission approve enactment of the proposed Ordinance that accompanies this memorandum.

ORDINANCE NO. 24-<u>05</u>

AN ORDINANCE TO AMEND CHAPTER 93 OF TITLE IX OF THE CODE OF ORDINANCES OF THE CITY OF SCOTTVILLE AND MATTERS RELATED THERETO

[To add regulations for use of riverbank of the Pere Marquette River in Riverside Park]
THE CITY OF SCOTTVILLE (the "City") ORDAINS:

Section 1. Amendment of Section 93.07 of Chapter 93 of Title IX of the City of Scottville Code of Ordinances. Section 93.07 of Chapter 93 of Title IX of the Scottville Code of Ordinances (the "City Code") is hereby amended to read in its entirety as follows:

§ 93.07 USE OF RIVERBANK

(A) No person shall utilize the riverbank of the Pere Marquette River within Riverside Park for ingress to or egress from the Pere Marquette River, to launch watercraft or other objects into the Pere Marquette River, or to retrieve watercraft or other objects from the Pere Marquette River. This prohibition includes, but is not limited to launching kayaks, canoes, paddle boards, and other watercraft; and use of the riverbank for swimming, wading, entering the river for the purpose of fishing, or other recreational activities. All access to the Pere Marquette River shall be made via the boat launch within Riverside Park and shall be in accordance with the provisions of the City Code and rules and regulations promulgated by the City with respect to Riverside Park as permitted in this Chapter.

- (B) For the purposes of this section, "riverbank" means the area beginning five (5) feet inland from the point where the land begins to slope downward toward the existing waterline of Pere Marquette River and ending five feet below the existing waterline of the Pere Marquette River, extending along the entire length of the Pere Marquette River as it runs through Riverside Park.
- (C) Any individual who violates this section is subject to a municipal civil infraction in accordance with § 10.99 of the City Code and subject to the following fines:
 - (1) The fine for any first offense of this section shall be not less than \$250, plus costs, expenses and other sanctions.
 - (2) The fine for any offense which is a first repeat offense, or any subsequent offense, of this section shall be not less than \$500, plus costs, expenses and other sanctions.

For the purposes of this section, "repeat offense" is defined in the same manner as § 10.99 of the City Code.

Section 2. Addition of Section 93.08 of Chapter 93 of Title IX of the City of Scottville Code of Ordinances. A new section, Section 93.08, entitled "Additional Rules," is hereby added to Chapter 93 of Title IX of the City Code to read in its entirety as follows:

§ 93.08 ADDITIONAL RULES.

The City Manager is empowered to make additional rules and regulations subject to the approval of the City Commission, pertaining to the conduct and use of parks and public grounds as are necessary to administer the same and to protect public property and the safety, health, morals, and welfare of the public, and any violation of the rules and regulations shall constitute and may be punished as a violation of this code by imposition of the penalty prescribed in § 10.99.

- <u>Section 3.</u> <u>Severability.</u> The terms and provisions of this Ordinance shall be deemed to be severable, and should any section, clause or provision hereof be declared to be invalid, the same shall not affect the validity of any other section, clause, or provision of the ordinance, if the same may be given effect without the provisions thus declared to be invalid.
- <u>Section 4.</u> Repeal. All resolutions or ordinances, and parts thereof, which are in conflict, in whole or in part, with any of the provisions of this Ordinance are hereby repealed.
- <u>Section 5.</u> <u>Effective Date; Publication.</u> A notice of adoption of this Ordinance shall be published in a newspaper of general circulation in the City within 15 days after adoption. This Ordinance shall take effect upon the expiration of seven days after publication.
